**NOTIFICATION**

New Delhi, the 14<sup>th</sup> June, 2005

G.S.R. 400 (E).-- In exercise of the powers conferred by section 5 of the Aircraft Act, 1934 (22 of 1934), the Central Government hereby makes the following rules further to amend the Aircraft Rules, 1937,namely:-

1. (1) These rules may be called the Aircraft (2nd Amendment) Rules, 2005.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Aircraft Rules, 1937, in Schedule II, Section J, paragraph 1, --
  - (i) in clause (e), for the words “two hundred fifty hours”, the words “two hundred hours” shall be substituted;

- (ii) in sub-clause (i), for the words “one hundred fifty hours”, the words “one hundred hours” shall be substituted;
- (iii) in sub-clause (ii), for the words “twenty five hours”, the words “twenty hours” shall be substituted.

Note:--

1. The principal rules were published in the Official Gazette vide notification number V-26, dated the 23<sup>rd</sup> March, 1937 and last amended by G.S.R. 330(E) dated the 20<sup>TH</sup> May,2005 published in the Extraordinary' Part II, section (3), sub-section (i) of the Gazette of India.
2. The Central Government in exercise of the powers conferred by proviso to section 14 of the Aircraft Act, 1934 (22 of 1934) has in the public interest dispensed with the condition of previous publication in case of this notification vide its Order No. AV.11012/7/2005-A dated 14-6-2005.2005 issued in the Ministry of Civil Aviation.
