NOTIFICATIONNew Delhi, the 18th July, 2001

GSR 399. - WHEREAS the draft of the Aircraft (Amendment) Rules, 2001, was published as required by section 14 of the Aircraft Act, 1934 (22 of 1934) in the Gazette of India, Part II, Section 3, Sub-section (i) dated the 28th April, 2001 with the notification of the Government of India in the Ministry of Civil Aviation No. GSR 233 dated the 12th April, 2001 inviting objections and suggestions from all persons likely to be affected thereby;

AND WHEREAS no objections or suggestions have been received on the said draft rules;

NOW, THEREFORE, in exercise of the powers conferred by Section 5 of the said Act, the Central Government hereby makes the following rules further to amend the Aircraft Rules, 1937, namely:-

- (1) These rules may be called the Aircraft (5th Amendment) Rules, 2001.
- (2) They shall come into force on the date of their final publication in the Official Gazette.

2. In the Aircraft Rules, 1937, after rule 61, the following rule shall inserted, namely:-

"61A. Validation of licences of foreign Aircraft Maintenance Engineers - When a licence to an Aircraft Maintenance Engineer has been granted by the duly competent authority in any Contracting State and is for the time being in force, the Central Government may, subject to such conditions and limitations and for such period as it thinks fit, confer on such licence the same validity for the purpose of maintaining/certifying aircrafts registered in India as if it had been granted under these rules and a licence so validated shall be subject to provisions of rule 19 and sub-rule (14) of rule 61."
