IMPORTANT INSTRUCTIONS TO CANDIDATES

1. **EXAMINATION SCHEME & SYLLABI:** Before filling up the application form, candidates are advised to go through the Section VII series B of the Civil Aviation Requirements (CAR), as amended from time to time, to get fully acquainted with the examination scheme & syllabi.
2. The application may be filled in capital letters by the candidates, in their own handwriting and be duly dated & signed. Incomplete & unsigned application forms will be summarily rejected.
3. **COMPUTER NUMBER:** A unique Computer number is allotted to every candidate by DGCA (viz CEO/FCE) in the first admit card and followed in all subsequent admit cards issued to a candidate. Computer number remains same for both Pilot General and Pilot Technical Examinations. Hence, the candidates are advised to fill in their computer number carefully, in the space provided. In case, the candidate has not been allotted with a computer number or is appearing first time, write "FRESH".
- 3.1 In case, it comes to notice that a candidate has written "FRESH" even though a computer number had already been allotted, the application is liable to be rejected. In case a candidate has been allotted with more than one computer number previously, all the computer numbers may be mentioned. The computer number given, thereafter in the admit card, will be the final computer number.
- 3.2. Computer number may be quoted invariably in all future correspondence concerning examination.

5. **EXAMINATION CATEGORY:** Candidate may write the category applied for in column 10(i).
6. **SESSION:** The candidate may write the session desired in item 10 (ii). Refer table 4 (a).

7. **CENTRE:** The candidate may choose only one centre & write the same with code in item 10(iii) & Synopsis Box. DGCA reserves the right to cancel any examination centre. In such an even the candidates will be allotted any one of the nearest centres. No correspondence will be entertained for change of centre.
8. **SUBJECTS:** The candidates may carefully write down each of the subjects in which they desire to appear for the relevant Examination category. Do not write 'All Subjects'. Each Subject name is to be written separately & fully in item 10(iv). Refer table 4(C)
9. **FEES:** Full amount of fee is payable irrespective of number of Subjects applied, through a demand draft/crossed Indian Postal Orders drawn in favour of 'Pay and Accounts Office, Director General of Civil Aviation, MCA, New Delhi. Fees once paid is non-refundable. Candidates are advised also to write their name, category & session on the reverse of fee instrument (viz. Demand Draft/I.P.O)
10. **SUBMISSION:** The complete application form along with fee Instrument may be submitted in an envelop superscribing "Application for Pilot General Examination:- ATTN FCE". Either by post or by hand addressed to 'The E.O.P.C/o Central Examination Organisation, Directorate General of Civil Aviation, East Block-III, R.K. Puram, New Delhi-110066.

11. **LAST DATE:** The last date for receipt of application form is the Last working day of the month preceeding the month of examination. No application received after last day will be considered for the concerned session under any circumstances, but will instead be carried over for the next session of the same category. DGCA does not take any responsibility for postal delays.
12. **ADMIT CARDS:** Candidates will be informed of the venue & time table of examination in the admit card, as early as possible. In case admit card is not received even by the 15th day of the Examination month, they may contact the Central Examination Organisation for guidance, so as not to miss the examination.
- 12.1 **IDENTITY:** Candidates are required to take along with them their pilot licence already held, in original or passport or driving licence to the examination venue for establishment of their identity. Certified photo on any letter pad as proof of identity is not acceptable. No candidate will be allowed to take the examination without valid proof of identity acceptable to the DGCA.
13. **FOREIGN NATIONALS:** Applications of foreign national should be forwarded through their sponsoring Indian Flying Clubs/Institutes, duly certified by the CFI, under the cover of the clubs/institutes forwarding letter, Govt. of India Clearance and a copy of passport should also accompany the application.
